The Beaumont Police Department is in compliance with the exemption requirements of Article 2.135 CCP regarding law enforcement motor vehicle audio and video recording equipment and recording retention.

Certification to This Report 2.132 (Tier 1) - Partial Exemption

Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling

The Beaumont Police Department has adopted a detailed written policy on racial profiling.

Our policy:

- (1) clearly defines acts constituting racial profiling;
- (2) strictly prohibits peace officers employed by the Beaumont Police Department from engaging in racial profiling;
- (3) implements a process by which an individual may file a complaint with the Beaumont Police Department if the individual believes that a peace officer employed by the Beaumont Police Department has engaged in racial profiling with respect to the individual;
- (4) provides public education relating to the agency's complaint process;
- (5) requires appropriate corrective action to be taken against a peace officer employed by the Beaumont Police Department who, after an investigation, is shown to have engaged in racial profiling in violation of the Beaumont Police Department's policy adopted under this article;
- (6) require collection of information relating to motor vehicle stops in which a citation is issued and to arrests made as a result of those stops, including information relating to:
  - (A) the race or ethnicity of the individual detained;
  - (B) whether a search was conducted and, if so, whether the individual detained
